3. The Agency agrees to pay "Voyzant LLC" any fees/penalties or debit memos issued by the airlines for any "HX" segments not being removed from any reservation re-released back into the "Agency" after ticketing and for any debit memos resulting from a NO SHOW.
4. The Agency agrees to pay "Voyzant LLC" any amounts due as a result of a cardholder disclaiming charges for ticket/s issued by "Voyzant LLC" including fees/penalties or debit memos associated with any credit card charge back or fraud issue committed by the passenger/cardholder.
5. The Agency agrees to pay "Voyzant LLC" any commission recall generated by the airlines on refunded tickets processed through Voyzant or the airlines directly.
6. The Agency will be fully responsible for advising passengers of any schedule changes or flight cancellations.
